In order to apply for a CDC, a person has to be an Indian national of 18 years old, with an Indian passport and a Class 10 pass certificate, and has to complete five basic International Convention on Standards of Training, Certification and Watchkeeping for Seafarers (STCW) safety courses.

What is exit exam by DGS?

Exit Exams ensure that like standardised E-Learning the assessment of the seafarers is also fair and ensure a standard competency of the seafarer with respect to the training. Since August 2020 Exit Exams are going to be mandatory for verification and certification of modular courses.
